**ORDINANCE NO. 00-03**

**AN ORDINANCE OF THE BOROUGH OF PICTURE ROCKS,  
LYCOMING COUNTY, PENNSYLVANIA, ESTABLISHING STOP SIGNS  
ON CERTAIN STREETS AND PROHIBITING PARKING ON CERTAIN  
STREETS.**

**IT IS HEREBY ENACTED AND ORDAINED** by the Borough Council of the Borough of Picture Rocks, Lycoming County, Pennsylvania, as follows:

**Section 1.**

**Stop Intersections Established**

The following intersections are established as stop intersections, and official stop signs shall be erected (or are ratified if previously erected) in such a position as to face traffic approaching the second named street (the intersecting or through street) on the first named street (the stop street) in the direction or directions indicated for that intersection. Every driver of a vehicle approaching the intersection on the first named or stopped street, in the direction indicated in each case, shall stop the vehicle as required by Section 3323(b) of the Vehicle Code and shall not proceed into or across the second - named or intersecting or through street until he has followed all applicable requirements of that section of the law.

**Section 2.**

**Penalty**

Any person who violates any provision of Section 1 shall, upon conviction, be sentenced to pay a fine and costs as established in the Pennsylvania Motor Vehicle Code for violations of Section 3323 (b).

**Section 3.**

**Parking Prohibited at all Times in Certain Locations**

Parking shall be prohibited at all times in the following locations:

<u>Street</u>	<u>Side</u>	<u>Between</u>
U.S. Rte. 220 (Main Street)	East	Southeast corner of Main and Elm Streets to a point located 250 feet south of said corner
U.S. Rte. 220 (Main Street)	East	Northeast corner of Main and Elm Streets to a point located 250 feet north of said corner
U.S. Rte. 220 (Main Street)	East	Between the intersection of the entrance to the Picture Rocks Fire Hall Building and Main Street to a point located 50 feet north of said intersection
U.S. Rte. 220 (Main Street)	East	Between the intersection of the entrance to the Picture Rocks Fire Hall Building and Main Street to a point located 50 feet south of said entrance

<u>Street</u>	<u>Side</u>	<u>Between</u>
U.S. Rte. 220 (Main Street)	East	From the southeast corner of Main and Water Street to a point located 250 feet south of said corner

**Section 4.**

**Penalty**

Any person who violates any provision of Section 3 shall, upon conviction, be sentenced to pay a fine of \$25.00 and costs; provided, however, that it shall be the duty of the law enforcement officer of the Borough to report to the Borough Secretary all violations of any provisions of Section 3, indicating, in each case the license number of the vehicle involved in the violation, the location where the violation took place and any other facts that might be necessary in order to secure a clear understanding of the circumstances attending the violation. The law enforcement officer making the report shall also attach to and place upon every such vehicle a notice stating that the vehicle was placed in violation of Section 3. The notice shall contain instructions to the owner or driver of the vehicle that if he will report to the office of the Borough Secretary and pay the sum of \$10.00 within ninety-six (96) hours after the time of the notice, that act shall save the violator from prosecution and from a payment of a fine \$25.00 and costs.

**Section 5.**

**Effective Date**

This Ordinance shall be effective immediately.
