

ORDINANCE NO. 2006-02

AN ORDINANCE OF THE BOROUGH OF PICTURE ROCKS, LYCOMING COUNTY, PENNSYLVANIA, VACATING PINE STREET, AN UNNAMED ALLEY AND A PORTION OF NORTH RAILROAD STREET.

BE IT ENACTED AND ORDAINED by the Council of the Borough of Picture Rocks, Lycoming County, Pennsylvania, and it is hereby ENACTED AND ORDAINED by the authority of the same as follows:

Section I

The entire length of an unopened street known as Pine Street is hereby vacated beginning at a point in the center line of North Main Street then proceeding in a westerly direction 495 feet to the end of the unopened street known as Pine Street. Exhibit "A".

Section II

The entire length of an unopened and unnamed alley is hereby vacated beginning at a point in the center line of North Main Street and proceeding in a westerly direction 310 feet to the end of the unnamed alley. Exhibit "B"

Section III

An unopened portion of North Railroad Street is hereby vacated beginning at a point in the center line of North Main Street then proceeding in a southwesterly direction approximately 700 feet. Exhibit "C".

Section IV

A copy of this Ordinance and Exhibits "A", "B" and "C" shall be filed with the Office of the Prothonotary, Lycoming County, Pennsylvania.

Section V

This Ordinance shall become effective forty (40) days after the filing of the copy as set forth in Section IV.
